

MINUTES OF THE SPECIAL MEETING OF THE BOARD OF EDUCATION OF CREVE COEUR SCHOOL DISTRICT NO. 76, HELD AT DISTRICT ADMINISTRATIVE OFFICE, 400 NORTH HIGHLAND AVENUE, CREVE COEUR, ILLINOIS, ON MAY 16, 2017

President Bailey called the meeting to order at 6:06 p.m. Answering roll call were Randy Giddens, Katherine Ragon Pam Greiner and Linda Bailey. Absent were Valerie Ragon and Savanna Tyler. Also present were Administrators Mr. Michael McCormick, Mr. Steve Johnson, Mr. Dan Jecks and Mr. Tony Whiston.

President Bailey announced that one letter of interest for the vacant school board position was received and that letter was from Mrs. Brenda Keogel. Mrs. Keogel read the Oath of Office and was seated at the board table.

Closed Session

Mrs. Greiner, seconded by Mrs. V. Ragon, made the motion that the Board of Education of Creve Coeur School District No. 76 finds that Student No. 17-03 was guilty of gross misconduct, as set forth in the Illinois School Code and in violation of School Board policies; it is further determined that Student No. 17-03 be and is hereby expelled from Creve Coeur School District No. 76, for the remainder of the 2016-2017 school year and the 2017-2018 school year. ROLL CALL VOTE-Yeas were Giddens, Keogel, K. Ragon, V. Ragon, Greiner and Bailey. Nays were none. Motion carried.

Mrs. Greiner, seconded by Miss K. Ragon, made the motion that the expulsion of Student No. 17-03 be held in abeyance to allow Student No. 17-03 to attend an alternative school if determined necessary by the manifestation hearing. Student 17-03 will not be allowed on district property or attend district events regardless of location until the end of the 2017-2018 school year. ROLL CALL VOTE-Yeas were Giddens, Keogel, K. Samantha Smith will be employed as a 10 month employee at \$14.50 per hour with additional training days for this year.
